**Tuition due dates:**

- **June 5<sup>th</sup>**
- **July 5<sup>th</sup> + Activity Fee**
- **August 2<sup>nd</sup> (last day of summer camp, prorated)**

### **Fees**

- Annual Registration Fee: \$45 Individual / \$75 Family
- Activity Fee (Drafted in July Tuition)
  - \$50 for preschool – K4
  - \$300 for school-age
- 2.9% Brightwheel credit and debit card processing fee

### **Discounts**

- Discounts are applied to tuition only.
- Multi-Child Discount
  - First Child – Full Tuition
  - Each additional sibling – 10% off total tuition

### **Waitlist**

- In the event a program is full, families may request to be placed on the waitlist until a spot becomes available.
- Applications must be submitted for a student to be placed on the waitlist.

### **Withdrawals**

- A 30-day notice is required to withdraw from summer camp. Tuition is due on the 5<sup>th</sup> of every month therefore, parents can withdraw their child without tuition responsibility until **May 4, 2024**. After this date, tuition responsibility is as followed:
  - **May 5<sup>th</sup>-June 4<sup>th</sup>**- Parents are responsible to pay 100% of June tuition per child.
  - **June 5<sup>th</sup>- July 4<sup>th</sup>**- Parents are responsible to pay 100% of July tuition per child.
  - **July 5<sup>th</sup>- August 2<sup>nd</sup>**- Parents are responsible to pay 100% of August tuition per child.
